
International Japanese Speech Contest

New Year event Hatsumode



"Hatsumode" is a New Year's event that we visit a shrine or temple for the first time in the new year. During the visit we pray for the safety and peace in the coming new year, as well as

giving gratitude for the last year.

Many temples and shrines ask for scattered worship to prevent the spread of the COVID infection. There may be restrictions on attending, so please check the official website before attending.

Here is the list of some shrines or temples in Fukuoka city:

- · Hakozaki Shrine in East ward It is famous for warding off evil influences and bringing good fortune. https://www.hakozakigu.or.jp/
- · Atago Shrine in West ward It is the oldest shrine in Fukuoka and atop a hill, where you can overlook the city of Fukuoka. http://atagojinjya.com/
- ·Sumiyoshi Shrine in Hakata ward is a seafarers Shinto shrine and presumably the oldest Shinto shrine in Kyushu. https://www.nihondaiichisumiyoshigu.jp/

New Year's Lucky charms

These are lucky charms that you will normally see in Japan from the end of December.



Hamaya - A decorative arrow sold at shrines and temples is said to capture the good luck of the year. It is customary to give to

someone who has had a house newly built or a newborn baby. The year after the Hamaya is displayed, it's returned to the shrine / temple while showing appreciation.



Shimenawa – Placed on the door outside (like a wreath), to welcome Toshigami-sama in to a place that is clean and sacred.







Kadomatsu – Is one of the New Year's decorations and marks, placed on both sides of an entrance to welcome Toshigami-sama in the new year. It is not good to set up Kadomatsu on New Year's Eve as it lacks sincerity, therefore it is better

to set it up around the 28th.



About Individual Number Card

Individual Number, also known as My Number is a 12-digit ID number issued to all citizens and (foreign) residents of Japan. An Individual Number Card is required for various procedures such as social security, tax, and natural disaster countermeasures. In addition, if you have an Individual Number Card, you can use it for various electronic applications such as electronic tax filing (e-TAX), which means you can complete the procedure from home!



Setsubun

The word Setsubun was originally a word that referred to the day before the beginning of spring, summer,

autumn, and winter. It is believed that evil spirits come at the turn of the season, and rituals are held to dispel them. Setsubun has changed with the



Fukumame (fortune beans) are either thrown out of the front door, or at a member of the family wearing an Oni (demon) mask while saying,

"Oni wa soto! Fuku wa uchi!" (Devils out, happiness in!).

Those who have paid Furusato Nozei

Furusato Nozei (donations to a Japanese city) is a tax scheme that refunds some of income and residency tax. If the donation exceeds 2,000 yen, tax will be refundable for that.

Please note that even if you have applied for the "One-stop exception", you will still need to file tax returns:

- When donating to 6 or more local governments
- · When filing for other reasons such as medical expense or mortgage deduction




Tax Return

The tax return is to calculate the tax on income from January 1st to December 31st of the year and report it to the tax office.

Even if you are not obligated to, by filling in a tax return, you may be able to receive the overpaid tax back. You are however obligated to file a tax return, if you have a certain amount of income. If you are obligated to file a tax return but do not file it by the deadline,

Main reasons for filing a tax return



- **★**There was a loss on stocks and/or foreign exchange.
- ★You paid Furusato Nozei, hometown tax or donated.
- *Unemployed and not re-employed before the end of the year.
- *Your annual medical expenses exceeded 100,000 yen. (or if it exceeds 5% of the annual income of earnings up to 2 million yen).
- ★Purchases of certain over-the-counter drugs* exceed 12,000 yen a year.
- (*Over-the-counter drugs are medicines sold directly to a consumer without a requirement for a prescription).
- **★**Damage to homes and/or property due to natural disasters, fires, theft, etc.
- ★You took out a mortgage for construction work on your property such as extension and/or restoration.

you may be penalized. It is possible to file a tax return retroactive for the past 5 years by requesting for rectification.



Main reasons for filing taxes

- *Sole proprietorship (self-employed or freelance).
- ★You become unemployed during the tax year (have not received year-end adjustments)
- *You have real estate income, or sold real estate and made a
- *Your annual earnings from salary exceeds 20 million yen.
- *You are in full time employment and the total amount of income from side business exceeds 200,000 yen.
- *For those who receive salaries from two or more places and they do not make year-end adjustments exceeds 200,000 yen.
- ★Your income from public pensions exceeds 4 million yen, or income from salary, real estate income, etc, exceeds 200,000 yen annually.
- ★You have not submitted the "Application Concerning Receipt of Retirement Income" after receiving the retirement allowance.

Tax return flow

Step 1. Prepare necessary

documents

You will need documents such as Individual Number* card

Notification Card, withholding tax slips from income and public pensions, donation receipt certificates, medical expense receipts, etc.

Step 2.

Fill out tax return

Fill out a tax return form by one of the three following methods

Method 1. Fill out a form on the National Tax Agency website below:

Step 3.

Submit

Submit your return to the tax office by either mailing it, taking it to a Tax Office or submission via e-Tax.

Submission time

Between February 16th and March 15th every year.

This year's is Wednesday, February 16th until Tuesday, March 15th, 2022. (It may change in the future.) *To reduce congestion, some tax return venues may issue a "numbered admission ticket" with a specific a submission time.

Bringing animal products into Japan from overseas



Don't bring illegal meat products into Japan. It's illegal to import most meat products into Japan.

Please refrain from illegally bringing meat and other livestock products from overseas into Japan. Doing so is punishable by up to three years in prison or a fine of up to 3 million yen (for corporations, up to 50 million yen). This includes meat products sent by international mail or shipping services.

Countries around the world are currently experiencing virulent livestock disease outbreaks such as foot-and-mouth disease and African swine fever. Should these diseases reach Japan, they could not only cause great harm to Japan's livestock industry, but also adversely impact socioeconomic activities in the affected region.

In fact, the African swine fever virus has been found in meat products brought into Japan by travelers, and there is increasing risk that livestock pathogens will reach Japan.

On July 1, 2020, Japan introduced stricter penalties for illegally bringing meat products into the country from overseas. Those measure are being accompanied by stepped-up monitoring of attempts to bring illegal meat products into the country in luggage or via international mail, for example by increasing the number of sniffer dogs used in plant and animal health inspections. Remember: It's illegal to bring meat products into Japan, even as souvenirs or for personal consumption. See here for details.

Fukuoka City Municipal Evening Junior High Schooling

The Fukuoka City Board of Education is taking all necessary preparatory steps towards starting

evening junior high school classes in Fukuoka City in April 2022.

The junior high school classes provide the opportunity to study in

the evening for all people regardless of nationality. This is education. open for those who want to relearn what they learned in

junior high school, or finish what they could not complete Student recruitment as planned for whatever reasons. Anyone over the compulsory education December, 2021 to February, 2022 age of 15 can apply.

- Study 5 days a week in the evenings.
- You do not have to pay tuition fees.
- Study the same subject as junior high schools.
- You will be taught by qualified junior high school teachers.
- You will graduate junior high school once you have completed the course.

The location: Fukuoka City Education Center (3-10-1 Momochi, Sawara-ku)

Eligibility. You must both:

Be registered as a resident in Fukuoka city, regardless of the nationality, and over 15 years old on 2nd April. And for any reason, have not completed compulsory
